- j) Rates quoted in the bid are to remain valid for a period of 12 months or any other extension thereof made by the authority after the last date for bid submission as specified in this e-NIT. Bids valid for a shorter period shall be rejected as non-responsive.
- k) If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation. An affidavit has to be supplied in this regard at the time of receiving supply order.
- I) West Bengal Handicrafts Development Corporation Limited shall ask for Performance Guarantee on value of work order as per Government rule.
- m) Payment shall be made only after the successful delivery and acceptance of supply and on receipt of payment from the buyer of MANJUSHA.
