Electronic-tender is hereby invited from the empanelled bonafide Manufacturers/ Suppliers/ Agencies/ Firms/ Individuals/ SHG/ Co- operative for Cotton Cloth Bag for Vending Machine as per Annexure-I.

- **This e-tender is being invited to enable West Bengal Handicrafts Development Corporation Ltd. (MANJUSHA) to obtain rates of Cotton Cloth Bag for Vending Machine at different places as directed by the buyers departments and as per stipulated specifications mentioned in Annexure- I.**
- **The exact value and quantity of supply can only be ascertained when actual order is received by West Bengal Handicrafts Development Corporation Ltd. (MANJUSHA) from the buyer.**

Terms and conditions

- a) Items/Products/Samples shall be accepted only if the specification fixed by buyer of WBHDCL is met and sample is approved by the buyer.
- b) First the credential documents shall be taken up for scrutiny and the eligible bidders who meet the credentials shall be listed. Thereafter the samples of the bidders only whose credentials are in order shall be examined in conformity with the buyers specification.
- c) Thereafter all the samples shall be sent to the buyer for their approval. The choice of the buyer shall be final and binding.
- d) If the buyer rejects any sample of any agency(s) on visual ground or any other ground, the item of the said rejected agency(s) shall not be considered for supply.
- e) The sample submitted by the bidder should not contain any mark/label of manufacturer or supplier anywhere on the body of sample.
- f) One bidder is allowed to submit only one variety of sample for the item.
- g) Financial bid of only those bidders shall be opened whose credentials are in order and sample approved by the buyer through written communication.
- h) The rates quoted by the Bidder shall be deemed to include GST, cost of packing, carrying and delivery up to all locations and in such batches as per delivery programme to be fixed from time to time.
- i) The supplier shall enter into MOU with the supplier for Cloth Bag Vending Machines to ensure 01 (one) year warranty from their end and to ensure its maintenance.
- j) The supplier will have to depute sufficient number of Manpower to fill up the bags in the machine when it reaches the Minimum Stock level.
- k) Rates quoted in the bid are to remain valid for a period of **18 months** or any other extension thereof made by the authority after the last date for bid submission as specified in this e-NIT. Bids valid for a shorter period shall be rejected as non-responsive.
- l) If the items/products are rejected by buyer at any stage (before or after supply), the entire consignment shall be cancelled without further clarification. No compensation can be claimed from the corporation. An affidavit has to be supplied in this regard at the time of receiving supply order.
- m) West Bengal Handicrafts Development Corporation Limited shall ask for Performance Guarantee on value of work order as per Government rule.
- n) Payment shall be made only after the successful delivery and acceptance of supply and on receipt of payment from the buyer of MANJUSHA.

In the event of e-filing, intending bidder may download the tender document from the website directly with the help of Digital Signature Certificate.

Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the website <https://wbtenders.gov.in>. Tender document may be downloaded from website & submission of Technical Bid/Financial Bid as per Tender time Schedule stated. The documents submitted by the bidders should be properly indexed & digitally signed.
